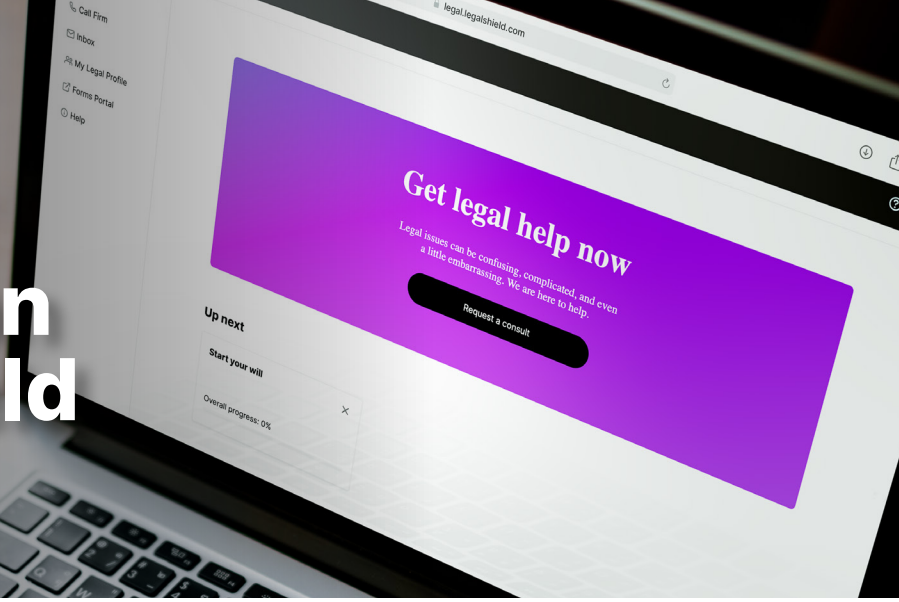

Letters and phone calls can be made on a participant's behalf to resolve legal matters such as warranty disputes or a dispute with a creditor.



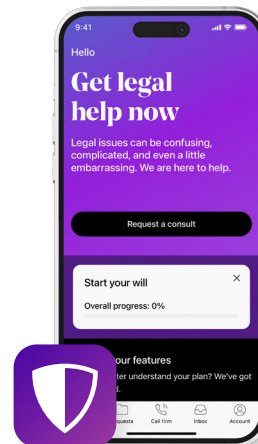

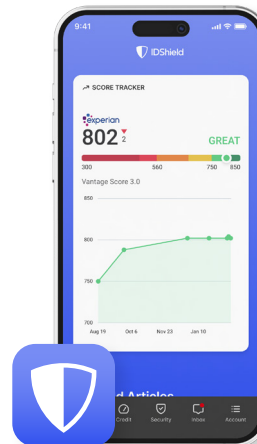
